## **Formality And Dress Codes by Randy Godfrey, 1st V.P.**

The night I was to be installed as your 2nd VP, we were all sitting around enjoying a happy hour, and when everyone started to leave to wash up for dinner, someone turned to me and asked if I was going to dress up for the installation. Dressed in a T-shirt, jeans, and hiking boots I said, “This was as good as I get.” A white shirt, red tie, and Blue Beret were tossed at me from various trailers, and thus I was introduced to one of the WBCCI’s customs—formal ceremonies and dress codes.

I later observed our president dressed in the WBCCI uniform of white shirt, red tie, dark pants and shoes, and beret in opening ceremonies at the FL State Rally, and Region 3 Rally. And, I did the same for our Unit at Bozeman last year, but I have been bothered about finding space in my small trailer for this uniform to be worn at a single activity and, aren’t we on a camping trip after all? The dress code requirements at Bozeman were onerous, and even if I had been your Unit President there, I wouldn’t have been able to attend the appreciation dinner as I didn’t

have a dark suit and tie in my Airstream's small closet.

To quote Phil Pons a life member of the WBCCI in the Mid-Atlantic Unit: "WBCCI has drifted away from being a caravanning and camping club to being an organization fixated on "structure" and hierarchy. An inordinate amount of time and energy is spent on formal events that seem to benefit a few but irritate many. Just look at the emphasis on uniforms. Not only the senior managers but also their distaff side wears distinctive uniforms that further separate them from the Club members. I suspect this practice crept into our Club through the influence of former military folks. This practice has lost favor in today's military and has outlived its value to our Club if it ever was of value."

After researching this topic, I have discovered that there are no rules on this, it is only custom handed down from earlier times when formality was more in vogue. In today's world though, this formality is being replaced. At the company from which I retired in 2007, we dropped the shirts and ties for "Business Casual" attire more than 10 years ago. At our Unit's installation of officers in 2008, I asked our region president about any requirements for the dress code and he told me it was whatever I wanted when I became president.

In an article I wrote for this newsletter after the Bozeman rally, I reported that our Unit Logo was being digitized by Allison and Wes of A&W Designs, the vendor who brings the embroidery machines to the FL State Rally. At our Unit luncheon at the Florida State Rally, I modeled this new shirt for everyone, and said I propose to wear this with the beret for my installation later this year, that is, unless you vote me out before then. This shirt is something we can wear for many occasions, and to a local restaurant for dinner without feeling over dressed. This doesn't replace the
