CRACKER CHRISTMAS VOLUNTEER/ INSTALLATION RALLY

Once again we will be at historic Fort Christmas. This not only is our annual Installation Rally it is also a Volunteer Rally where we assist Fort Christmas in running CRACKER CHRISTMAS. Last December we had over 25,000 people attend, plus we had 25 Airstreams on the grounds. For those of you that have not been here, we volunteer being docents at the restored Cracker homes and the restored fort. There are approximately a dozen buildings on the grounds now and help is needed including a Mr. and Mrs. Clause. We will be provided water and about 10 amps of electric per vehicle. We will also have our members to teach you and check things on your rig, FREE ADVICE. There will be get togethers and/or seminars every evening. There will be one of Central Florida's largest craft fairs on the weekend with over 150 crafters on the grounds. This is a do not miss rally. Members that do not tow are welcome to the Thursday, night supper, December 3 free of charge. Reservations a must and please bring table service.

Your rally fee of \$15.00 per person will include nine meals including one potluck where you will be asked to furnish a side dish to feed 6 to 8 people. The meat will be supplied and cooked on an open fire. You will be parked on grass, and we will try to accommodate everyone. The Installation dinner will be on Thursday evening and the menu will be a smoked turkey dinner. The dress code as requested buy our incoming President, Randy, will be casual with either one of our Unit "T" shirts. If you have not received your shirt, be sure to see Dave or Betty at the rally. RESERVATIONS ARE A MUST! This is a fun rally and one of the most reasonable. There will be 4 breakfasts, 3 dinners 2 lunches If you can only come for Friday night Saturday and Sunday, there is no rally fee, but there will be 5 meals. You will need to bring a side dish for Friday evening supper.
