THURSDAY, JUNE 30, 2011,  
DELEGATES MEETING

Another hot day in Illinois. Got up early this morning to get to the SIC building and the WBCCI Delegates Meeting at 8:00 a.m.

Most people, except those who wished to be noticed, were dressed in their WBCCI finest, berets, white shirts or blouses, dark skirts or slacks and black shoes. Neckties were optional. There were 108 delegates present along with Region Officers and International Officers. Also on hand, were a number of "spectators" to watch the proceedings.

After the Opening Ceremony, Invocation, and Pledge of Allegiance, President Norm Beu opened the meeting. He stated the protocols for speaking and so forth.

Then there was the roll call of delegates. Essentially finding out what Units were NOT there. I think there were 17 out of 125 Units absent.

President Norm Beu gave his report, mostly thank you's and so on. No "State of the Club" remarks which I thought would have been appropriate, but I'm only a rookie.

There was no correspondence, the reading of last year's minutes was waived, and the Treasurer couldn't really give a report, because the Fiscal year was not over. He did say however, that the Rally and the WBCCI would finish this year

in the black. That certainly is a compliment to all the Regional and International Officers.

Next up was the Election of the International Officers, a lengthy procedure. Past President Tom Collier gave the Nominating Committee Report and presented the slate of Officers for the 2011 - 2012 year.

After some discussion and the opening and closing of nominations from the floor (there were none), the slate of officers was declared elected without polling the delegates as provided for in our Constitution.

President Beu then stated that there would be no vote this year on amending the Constitution as the membership needed time to review the matter and provide input into the proposed changes. There was no discussion.

There was no Unfinished Business to be discussed.

For New Business, a motion was presented by C.C. Gartman, Region 9 President, concerning the listing of all qualified International Officer Candidates information, i.e., resumes, and inserting them in the April Blue Beret. After some orderly and intelligent discussion, the Amendment was

adopted by the Delegates. A roll call vote was taken and each Delegate present voted for his or her Unit. I voted all the Florida Unit's 65 votes for this motion as it was and is my opinion that the motion was for the good of the Club. The motion passed unanimously, receiving over 4,000 yeas votes.

There being no further business, the meeting was ad-

joined by President Beu. Delegates were asked to be back in 20 minutes for the start of a seminar that would address the proposed revisions to the WBCCI Constitution.

I was impressed by how orderly and effectively the meeting was carried out. The International Officers had obviously done their homework. The Delegates conducted themselves

professionally. I have attended other club and fraternal meetings of this nature and the WBCCI is certainly on a par with other organizations of this type.

#### ON THE ROAD WITH HOWARD & SUSAN LAROSE

We left Palm Bay the last week of April and headed to the Tennessee Airstream Park (TCPC). We were delighted when George & Pam Millis stopped by on their way to Alaska. One day we took them to Fall Creek Falls State Park to see waterfalls, the visitor center, and Buzzard's Roost. Another day we had lunch at the Cumberland Mountain State Park restaurant, and then we toured the Homestead Tower and Museum, and the historic Homestead House.

In late May, we headed north in the B-Van to Apple Valley, Minnesota, to meet our new granddaughter Kate, born March 7, and to spend time with her brother Ethan, age 2.

We then drove to South Dakota's Badlands (new, very informative visitor center), Mt. Rushmore, Crazy Horse Memorial, and historic Deadwood. We discovered a hidden jewel, Spearfish Canyon, a beautiful 13 mile drive (one way) with three thundering waterfalls.

Devil's Tower was next and we hiked around the base. In Cody, Wyoming, we toured the Buffalo Bill Historic Center, actually five museums in one, and referred to as "The Smithsonian of the West." We drove west into Shoshone Canyon and the east

Yellowstone Park entrance. Yellowstone and the Great Tetons had double the usual amount of snow and most of it had not melted. The Teton Range reminded us of the mountains in Alaska and British Columbia—breathtaking. Moose Junction has a huge new visitor center, and when the video ends, the drapes open for a view of the snow-covered mountains. For you birders, there were 15 white pelicans below Jackson Dam. Jackson Hole is our favorite place in the US.

Heading back east, we enjoyed the mountain man rendezvous at Ft. Laramie. Re-enactors authentically portrayed an 1836 fur trade camp. Next was the fur trade museum in Chadron, Nebraska, and then the Atka Lakota Museum in Chamberlain, South Dakota, where a time line showed the history of the Plains Indians (good exhibits too). Nearby we toured the Lewis & Clark Visitor Center on I-90.

Our last stop was in Apple Valley enjoying the grandkids again. We are now back at the Tennessee Airstream Park until mid-September. If any of you are nearby, send us an e-mail and we'll make plans to show you around this area.

NOTES FROM INTERNATIONAL

Our International President, Norm Beu, writes:

“Friends, I have received sufficient feedback from some of you and from individual members at rallies which makes it necessary for me to markedly change the processing of the proposed Constitutional Revision. It is currently on the agenda for the Delegates’ Meeting, June 30, at the International Convention/ Rally. Only one month has passed since the proposed Constitutional Revision was distributed to our Units. In retrospect, it was unreasonable to expect all Units to have scheduled business meetings, understand the Proposal, and vote on each of the Articles. Due to the pressures of time, the

Executive Committee established an unrealistic schedule for our Units. It was an easy trap to fall into, with only one Delegates’ Meeting each year. Nevertheless, if revising the Club Constitution is worth doing, it is worth doing well.

“I profoundly appreciate the work done by the Revision Committee. This Committee of five has much time invested in the Proposal during the prior ten months. I sincerely value the alternative ideas as well, some of which have been expressed to me very passionately. Throughout the Membership there is much concern for the future of our Club. If nothing else, work done so far now has members (who are interested in Club governance) talking about what we want for a Constitution.

“My judgement is that the membership is not prepared to make decisions at this time, and that they want an additional year for consideration. Therefore, I will not make the motion concerning the proposed Revision during the next Delegates’ Meeting. Barry Heckenswiler has indicated that he will place the proposal on the 2012 Delegates’ agenda so that members’ discussions can continue. My intention is to solicit discussion at a Delegates’ Seminar. Those Units who do have prepared amendments to the proposed Revision are encouraged to present them. Other members with ideas and comments may present those as well. This will provide all members with additional material for dis-

cussion without the formality of a business meeting.

“I ask that you advise your Region Officers and Unit Presidents that the proposed Constitutional Revision will be discussed during a Delegates’ Seminar, but not voted on during the Delegates’ Meeting as originally scheduled.”
