The Denver Colorado Unit MOVES to STRIKE from the WBCCI Constitution, Sec. 4 of ARTICLE IX, BOARD OF TRUSTEES and in its place INSERT, under ARTICLE XII, DELEGATES MEETINGS, the words, "The Delegates shall have full authority to construe and interpret the Club's Constitution and annually review and/or repeal any Club Bylaw and/or Policy." All our Unit members received a complete package on this amendment with our September 2011 newsletter.
