When Elsie and I arrived at Sunshine Key RV Resort my brother Dan had already checked us in, setup his 54 Cruiser, and was ready to go.




There were a few others there and the rest arrived the following day. At our first happy hour we discussed the Conch Tour and many things the area had to offer.

I recently sent out a lot of information on the issues that will be discussed and voted on at the International Rally. I urge you to read over the material and if you have any questions, to call or send them to me. I'll do my best to answer them. After you have read this material, **I need you to let me know how you want me to vote on the issues.** I want to have a sense of how our Unit feels so that I can go the International and make good choices for all of us.

We need a Recording Secretary for our Unit. Unfortunately, Luann Carra had to resign due to conflicts with her work. We are already missing you Luann, and we wish you well. The Unit

Recording Secretary takes notes at the Unit and Executive Board meetings. It's not really a difficult job, just an important one that needs doing. If you think you can help out with this, please call or email.

Recently, Ron and Chris Allen went to visit Dave and Betty Wenger. Dave has the "Hopper" at his place in Maitland, and the group made a good inventory of the contents. For those of you who don't know, the "Hopper" is an enclosed utility trailer, made by Airstream, that holds our inventory of rally supplies. This includes, cooking utensils of all descriptions, coffee pots, plasticware, flags, etc. The complete inventory will be on our website soon if you want to look at it. It's our stuff! During a routine PET scan, a small mass was discovered in my lower back near my right kidney, my only kidney, so I had to have

a biopsy. Today [5/4/12] we went to the oncologist for results. As the mass is near my kidney, it is related in some way to the kidney's, renal cells, and we must be careful. Conventional chemotherapy is considered to be ineffective for this, surgery is also out. I may have radiation, but that still has to be discussed among the doctors. I will be taking a pill, for the rest of my life or until they come up with something better that prevents the mass from growing. That works for me. The side effects aren't too bad, and if they are, there are other pills that do the same thing that might work out better.

We are still planning to go to the International Rally in June/July and then God willing, do some traveling out west. For the moment though, I am lying low, waiting to see how the pills affect me—they had to special order them, and I probably won't get them for a week. (That's because I'm the President)

Now, all of you with no real serious health issues today, dust off the trailer and get out of Dodge! Take that trip, go see the relatives (they can't be that bad), use that Airstream for what it was made for! In the words of Dinah Shore, "SEE THE USA"

And, it is not too late to sign up for the International Rally in Sedalia MO. Come join us and the Allen's for a great rally.

 SOME FINAL NOTES FROM PHIL

This newsletter is an important one because it is the last time we have to talk before I have to represent you at International. I hope that you have read my lengthy email on the issues and perhaps even read some of the additional information. Please call me if you need more information.

Last year in DuQuoin, the revised Constitution for the WBCCI came up. Because it was late in getting out to the membership, action on this was postponed until this year. Last year we also voted on the Denco Amendment to the Constitution. This is now being ratified by the units. Our Unit voted to approve the amendment last November and (there was some confusion) the result of the vote has now been sent to WBCCI.

This year a vote will be taken on the revised Constitution. This is proposed Amendment One to our current Constitution. There is also an Amendment Two, that if passed would change the wording of our Constitution to allow Life Members to replace their aging Airstream motor homes with a

Thor branded product. As a member of the Florida Unit and the WBCCI, you should read the new Constitution and proposed Amendment Two, and decide how you want me to vote.

There seems to be a lot of opposition to the new Constitution, and I tend to agree. There is also a lot of opposition to Amendment Two. In 2007, 87% of the WBCCI voted NO on this, and here it is again. I am not trying to make up your mind for you, but just letting you know about where I stand. It is up to you to decide for yourself.

Because of my health issues, I had to cancel the Unit Meeting scheduled for May 12th at the Cedar Key Rally. I asked our newsletter editor to put a ballot and voting instructions in this newsletter [see last page] so that I can hear your voice. I will count the votes and vote according to the wishes of the Unit. The results of the voting will be published in the next newsletter.
