The Daytona Beach KOA provides us 30/50 amp electric, and water at each site. Dump station, restrooms, and recreation hall for our use at a discounted parking fee of \$15.00 per night. The parking fee is paid directly to the campground at check-in.

Your rally fee of \$18.00 per person includes four meals and a desert: Continental breakfasts Friday and Saturday morning, Ziti and meatballs Saturday night and ice cream desert, and a hamburger/hot dog dinner with all the fix-en's on Sunday night. After about six weeks recuperation at home, I have started chemotherapy to remove anything that might have been missed. The surgeons did find some very small spots that needed treatment, but are too small for radiation or surgery. Hence, the chemo. Chemo is no fun, the side effects stink, My treatments are every three weeks and it takes at least two weeks to get over the treatment. But, I'll be done with them in October and that's a plus. We may even take the cover off the truck, get the trailer out of storage, and get "ON THE ROAD AGAIN!"

I'm not sure if we will have our Airstream at Daytona. My final chemo is scheduled for Monday of that week and hooking up and packing may be beyond us. I do plan to attend the meeting on Saturday. If my plans go awry, Ron Allen is quite capable of taking over. It's nice to have great back-ups.

To all of those who have wished me well, my thanks to you. It is encouraging to know that folks think about you and care.

One last note here. I want to thank my wife Doris for all that she has done for me these past months. She has been my nurse, my cook, my love, and my inspiration. She just keeps saying, we'll get through this. God Bless you. I love you.

CRACKER CHRISTMAS VOLUNTEER AND INSTALLATION RALLY

The last Unit Rally of the year is our annual Cracker Christmas Volunteer and Installation Rally; November 27 – December 3, 2012, at Fort Christmas Historical Park in Christmas, FL. This is our annual rally where we help the Fort Christmas folks get ready for their biggest event of the year, and then we help them carry it out. We will also install our Unit Officers for 2013 at this rally. It's great fun and we always get a good turnout.

Orange County Parks relies on us to provide staffing for the historic homes and venues for the Cracker Christmas Festival on Saturday and Sunday. If you are coming, we ask you to please commit to staying through the end of the event on Sunday at 4:00 p.m. so that we can have adequate support for both days of activity.

The rally fee is \$16.00 per person. You will have 10 amp

rally electric and water. There are also flush toilets. A dump station is available at Christmas, FL RV Park for \$10.00. If you can only come for the weekend (Friday, Saturday, and Sunday) there is no fee. The rally fee includes the Installation dinner on Thursday, a total of about 10 meals if you're coming for the full 5 days. Six of the meals are scheduled on the weekend, and these too are no charge if you can only come for the weekend.

Rally parking begins on Tuesday, November 27. The parking committee should arrive no earlier than Monday, November 26. Our Unit dinner and Installation of Unit Officers for 2011 will be held on Thursday, November 29. Members that still belong to our Unit and the WBCCI but have no Airstreams are welcome to attend the dinner and installation; please let us know that you are coming. Day visitors are also welcome. Just provide us with advance notice, so that we will know to expect you.

We are the only group that is permitted to park overnight at Fort Christmas Historical Park. No other Airstream, Good Sam, or other RV groups are permit-

ted to camp in this Orange County Park. On the park grounds is a completely reconstructed fort from the Second Seminole Indian War. There are also about a dozen restored Cracker homes, a school, and a 1950s house. During your stay, one of the largest craft shows in Central Florida will take place on the grounds. On Saturday and Sunday you can expect to see between 20,000 and 25,000 people in attendance.

If you have never been to one of our rallies, this is the one to come to. Because of space, our Unit members and affiliates have priority at this rally, so **preregistration even for weekenders is a must.**

Come join us at the 40th Florida State Rally. It just doesn't get any better than this folks!

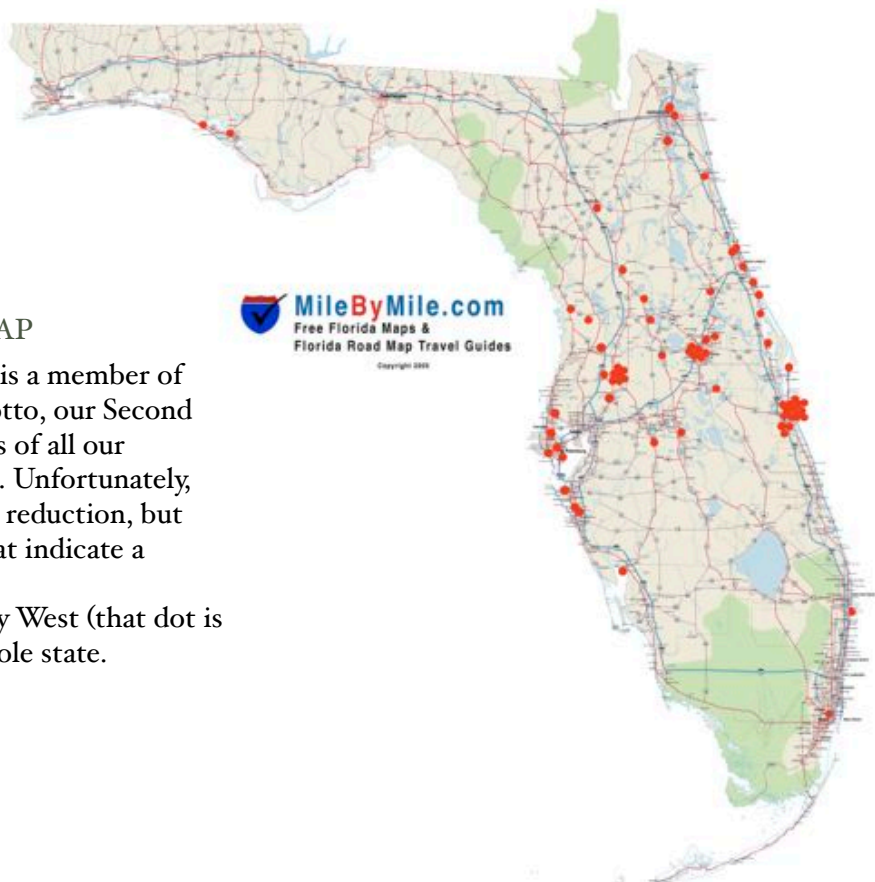
THE KEYS TO THE TROPICS RALLY FOR 2013

DO YOU HAVE A DIGITAL ESTATE PLAN?

Sooner or later, we'll all kick the bucket, buy the farm, or shed the mortal coil. But when you go, what will happen to your online accounts? You may or may not be content to just leave your Gmail or Facebook account dormant. You may have photos or documents in cloud storage. What if you have money in your Paypal account? And will your surviving relatives have the keys to your online banking or investment portfolio?



Also keep in mind that email and social network accounts can get hacked. Families and friends have been traumatized by spam sent from the accounts of the deceased. It can be difficult for survivors to get online accounts shut down after someone dies. Sometimes, it requires an expensive lawsuit or other court action.

Facebook, Twitter, Gmail, and some other major online services have procedures for handling the accounts of deceased members. In most cases, they require faxed copies of a death certificate, the photo ID of the requestor, and a notarized statement of authority. But Amazon, Grooveshark, Foursquare, and many others don't publish any information about dealing with deceased members' accounts. The [DeceasedAccount](#) website offers a handy guide to the deceased-member policies of many online services.

The simplest solution is to write down all of your accounts and their login credentials, then give that

list to someone you trust. Of course, you'll have to remember to constantly update that document when you change passwords or create new accounts. But what if you don't trust anyone with all of your digital keys, at least while you're still alive?

[DeadmansSwitch.net](#) lets you send emails after you die. An email to your executor, for instance, might contain a list of accounts and passwords or a full-blown digital will and testament. The service sends a check-in email to you every so often; you confirm that you're still alive by clicking on a reply link. If you don't reply within 60 days, you are presumed to be dead and your stored emails are sent. The free version supports up to two recipients. For a one-time fee of \$20, you get up to 100 recipients and the ability to customize the check-in intervals and reply deadline.

[SecureSafe.com](#) adds cloud storage to the posthumous email solution. You can upload documents and other files that will be sent to recipients upon your presumed death. Each file gets assigned to a beneficiary, so you can leave different things to different people. The free version supports storage of up to 50 account passwords, while paid versions provide more storage space and security such as two-factor authentication that beneficiaries must provide to access their bequests.

[The Digital Beyond](#) is a news and information site devoted to digital estate planning. It offers a directory of services similar to those mentioned above; links to news articles on the subject; and a book called, "Your Digital Afterlife" that can help you consider what your digital legacy should be and set it up according to your final wishes.

What do you want done with your email after you die? Many people want a relative to login and send a message to all contacts with their news of their passing.

Should your Facebook page be closed or converted into a "memorial page"? How much money do you keep in Paypal, and who should get it when you die? How about your digital photos stored on Flickr? Do you have a blog or website that may need to be closed down? These and many other questions are worth answering before you go.

ALASKA FOR THE SUMMER

By the time you read this, the 2012 WBCCI Alyeska (Alaska) Caravan will be over. We are Prince George, BC, the last stop on the caravan. The final banquet is tonight.

After my last newsletter, we traveled on to Dawson Creek, BC to rendezvous with the caravan. Someone asked me where we were going in Alaska, and my answer was every paved highway. Well, that turned out to be mostly correct. There wasn't any paved roads that we missed, and we also traveled some of the dirt roads too. The "Top of the World Highway" from Dawson City, BC to Chicken, AK



was the most "exciting." One hundred miles of dirt! Everyone on the caravan had a unique experience on that road, from minor dirt leaks, to doors falling off, to the worst case: One caravaner left their ceiling fans on sucking in dirt and dust, their water pump was also left on and the bouncing caused it to pump water into a sink that overflowed creating a mud slurry inside. We found some dust leaks we didn't know we had, and I'll need a shop vac to clean out my wheel wells when we get home.

After we entered Alaska, we traveled up to Fairbanks, which was our most northerly destination. The days were very long, often not getting dark at all, just no sun in the sky. We didn't find that to be



a problem at all because at the end of the day we were pretty tired from all the activity. From Fairbanks we went south, stopping at Denali National

Park. We took an all day tour into the park. It was cloudy, so we didn't get any good views of Mt. McKinley, but did see a lot of wildlife. On the day we left it was clear and sunny with good views of the mountain from every turnout.



Our next stop was Anchorage, then south to Seward, Homer, and Kenai. The Kenai Peninsula didn't disappoint with its scenic vistas and glacier tours. For the fishermen in the group, the fishing was great, and all caught their limit of Halibut. We had a great fish-fry in the campground.

After leaving the Kenai Peninsula, we made a brief stop at Palmer, a that's almost a northern suburb of Anchorage. We then around the mountain range that's a backdrop for Anchorage, and south again to Valdez. The drive to Valdez presented some of the most spectacular scenery of the trip, as we drove down to the sea through canyons and glaciers.



From Valdez, we began our trip out of Alaska by driving into Canada, then back into Southeast Alaska where we visited the cities of Haines, Juneau (by boat from Haines), and Hyder where the

black bears roam the streets. It was pretty amusing to watch the shop keepers chase the bears away with slingshots and rubber bullets, so their customers could get to the store.

When we drove up here in July, it was warm and sunny. Everything was green and the Fireweed was in full bloom. We even had the AC on in the trailer on some days. Now it's getting cold and winter is approaching fast. On our last two mornings on the Alaska Highway the low was 28°! All the fall colors are ablaze and the

Fireweed has turned to cotton. "When the Fireweed turns to cotton, summer is soon forgotten."

Tomorrow, we start for home. We'll be traveling down the western states, then



across the Southwest. We thought since we were so far west, that we would try to stop at some of the great National Parks out here, like Yosemite, and Grand Canyon. We are starting to look forward to getting home, and expect to get there in mid-October. I've got a list of things to fix when were not moving for a while, nothing major, but the nearly 12,000 miles we will have driven, causes some wear and tear.

If you were following me on my travel blog, I apologize for it going hopelessly behind. With very little Internet availability, often no phone service, and all the caravan activity, there really hasn't been time to process the thousands of photos and write a daily log. I've kept good notes though, and hope to start bringing it up to date as we make our way back home. My facebook and twitter posts have been current. Watch for a slide-show at one of our Unit rallies soon.

MEMBERSHIP NOTES

Don Clarke

Hi friends. On February 9th I celebrated 30 years since I retired as a Lieutenant on the New York City Fire Department. It was the best job that I ever had in my entire life. I could not imagine doing any other type of work that would bring so much satisfaction to me, and I looked forward to going to work every day of my 20-year career. Well, on that day, there were other plans that would unfold that I did not expect.

I had been weeding in my yard and developed a severe headache and was very short of breath. I went into the house and told Lucille that I did not feel right, so I took my blood pressure, and it was extremely high. I immediately contacted my family physician, and was later that day admitted to Florida Heart Hospital. I was diagnosed with 98% blockage in three arteries. Days later I had open heart surgery. As you might expect these days, heart surgery is nothing new and the procedure went along wonderfully. I had three arteries replaced and had started on the road to recovery. Open heart surgery was nothing, even remotely, what I thought it would be, and even though it probably is one of the worst surgeries a person can have, it went well, and I was not in extreme pain as I thought would be the result.

Following the surgery I had to go to cardiac rehab for three months, and I looked forward to it because I knew in my heart that it was what I needed to keep my life going. About a month into the cardiac rehab I was already walking five miles and before that I was not able to walk around the block in my neighborhood.

One morning, I was walking, not even two minutes from my house, and felt a pain over my heart. My right arm went numb. I went back into the hospital, and was diagnosed with a failing artery, and suffered a heart attack. I am told that about 10% of bypass operations have this effect.

Even though all this was taking place, I have continued praising God for the life that He has given me, and I continue to think that I am the most fortunate person in this world. I have survived two cancers, and now open heart surgery. Only God Almighty knows what will come next. I have a wonderful life, a very happy home, a beautiful wife, a loving family, and many friends. There is nothing that I am lacking, and I appreciate every blessing and trial that comes my way. This whole experience has made me stronger and able to endure what shows up in my life.

I want to thank every one of you who have thought about me, and the kind words, thoughts, and prayers that were sent my way. I send you all my love and best wishes.
