CRACKER CHRISTMAS VOLUNTEER AND INSTALLATION RALLY; CHRISTMAS, FL;
DECEMBER 4 - 9, 2013

For those of you that have never been to Cracker Christmas, this is what to expect.

We park on basically level grass. We will have water and 10 amp electric. Parking is free and the rally fee is \$16.00 per person. Included in the rally fee is a hoagie supper on Wednesday evening with any side dish you wish to bring. Thursday evening will be the Installation dinner supplied by the Unit from Boston Market. Friday will be a pulled pork potluck. We ask everyone to bring a side dish, enough to feed 6 to 8 people. Saturday will be a light breakfast, lunch and a dinner with the meat entrée roasted over a campfire. This is also a potluck with you bringing a side dish to feed 6 to 8 people. Sunday, a light breakfast and lunch. Sunday night will be on your own. Every afternoon there will be a happy hour so you will need your chairs and a snack table. Maybe you will be lucky enough to win an Earl Trask table. Bring a light snack and a beverage. For those of you that are new, these happy hours are a great time to ask any questions about the club and your Airstream.

During the time you are at Fort Christmas you will be asked to assist the employees at the park by helping to tidy-up and decorate the restored build-

ings, set up tents, tables and chairs. On the weekend, we docent the buildings for 3 hours a day.

What's at Fort Christmas? There are about a dozen restored Cracker homes and a reconstructed fort from the Second Seminole Indian War. There will be cane grinding, rope making, rug hooking, etc., plus one of Central Florida's largest craft fairs with close to 200 crafters. Last year we had over 30,000 visitors over the two-day weekend.

For those of you that cannot come until Friday, there is no rally fee. The only stipulation is **you must pre register** since we have to order food. Exciting news! Our own Tom and Dan Maciejczyk have decided to restart the Florida State Rally. 2014 will start a new era for Florida's longest running rally. Tom and Dan are starting fresh, everything will be new, and the Florida Unit is the sponsoring unit.

Instead of being at the same location every year, Tom and Dan are creating a moving rally. In 2014 the rally will be held in the Florida Keys. The plans for 2015 are to have the rally in St. Augustine. After that, they hope to change locations each year from north to south to place the event in new, historical locations so that each year you can attend and have a new adventure.

The 2014 Florida State Rally attendees will enjoy the historic sites and old charm of Key West. A trolley tour will get you around the most southern city of Key West. Airstreaming seminars, flea market, dinner and entertainment await your return to camp at mile marker 39. Sunshine Key Resort (an Encore park) has 360° views of tropical island life. There are amenities such as a swimming pool, tennis court, game room, fishing pier and a café on the grounds. Boat slips at the marina await your fishing adventure, also kayaking and canoe tours are a great way to see what island birds and sea creatures inhabit the Florida Keys (charters and tours are available at extra cost).

The cost for this rally is \$260.00 based on 2 people per unit (one person \$221.00). Included in the Rally Fee: 5 nights in the Florida Keys, parking with 5 point hook up (water, 50 amp electric, sewer, cable and Wi-Fi), use of trolley, seminars, a dinner and entertainment. Attendance in 2014 is limited to 120 full service sites, so this will be first come, first serve. For those wishing to come early or wishing to stay later, an extra day's fee at Sunshine Key Resort will be \$30.00 per night.

EXPLORING AMELIA ISLAND WITH HOWARD & SUSAN LAROSE

The last Sunday in September we packed the B-Van and headed north to Amelia Island, specifically to Ft. Clinch State Park. We chose this park because it is only an hour's drive to St. Mary's, Georgia, where we had reservations for the Cumberland Queen to the famous Cumberland Island National Seashore.

Ft. Clinch State Park has a real fort and it is well furnished. The small museum has an excellent video narrated by “soldiers” and we recommend the museum before touring the fort. Park rangers in Union soldier uniforms take visitors back to 1864. Visitors see the interiors of many buildings and also see broad views of the harbor and the Atlantic.

We camped in the Amelia River campground which was shaded with live oaks draped with Spanish moss. The other campground was close to the beach and provided no shade, but it was closer to the fishing pier. As we stood on the boardwalk, a Navy submarine escorted by two Navy ships was heading out into the Atlantic.

On the morning of October 1st, the government shut down and closed Cumberland Island National Seashore, so we drove to nearby historic downtown Fernadina Beach; charming like Key West but minus the crowds. We purchased tickets for a two hour boat tour from Amelia Island Cruises. We cruised down the Amelia River while learning so much from the excellent narration. Soon we were in Georgia and into the

wetlands of Cumberland Island. The boat was not allowed to dock, but the captain related the fascinating history of Cumberland Island. We saw dolphins twice, and even observed the “strand feeding” ironically just as the captain was explaining it! We saw wild horses in three areas and had a distant view of the burned Carnegie mansion ruins. After our boat tour, we had dinner across the street at the Salty Pelican (2nd level, overlooking the river), and of course, we ordered locally caught shrimp!

On Wednesday morning when we hiked the Willow Pond Trail, we saw or heard so many birds. We drove to the south end of Amelia Island (gorgeous homes) and passed three more state parks, one of them a fishing state park which was an old highway across the water. Further south, we boarded the ferry to cross the St. John’s River. It was a fun trip!

BRAD, JANET, AND ROBERT’S
1966 AIRSTREAM SAFARI
PART II

When taking on a project of this size and complexity it can be difficult to know where to begin. Let us start with the expression “they all leak.” In my research on restoring vintage Airstreams, water leaking is a very common theme and some water damage is almost expected. When I purchased my vintage Airstream the seller informed me that it did not leak. The trailer had been sitting outside on a concrete pad for three years and the floor always remained dry. At my first untrained inspection, the floor did appear to be very solid and only minor moisture damage was present around the bottom of some of the cabinets where carpeting was formerly installed.

I have now owned the trailer several months and have developed a trained eye. I can assure you, it does leak. Over the years, the non-aluminum components deteriorate. The sealant in the seams and around the doors/windows dries and cracks allowing water to seep inside. The original refrigerator vent cover, plumbing vents and stove vent cover were fiberglass and have deteriorated. The



exterior marker lights are very faded and failing.

The 1966 – 1968 Airstreams have curved Corning glass. The glass is no longer made and until recently there was no option to replace the glass except with plastic. The plastic does bend to match the side of the trailer but



not exactly leaving gaps where water can get in. In addition, the rubber seals around all of the windows and door are dried

and failing. No wonder it leaks.

Making the Airstream waterproof is a priority to reduce the potential for further damage. It is time to move to inside storage. The storage garage I rent is about 40 feet long so there is plenty of room to store parts and work. It is



a little tricky to get the trailer in and out because the driveway is a little narrow but it will work until another unit with easier access is available. I am going to start the restoration by focusing on waterproofing the exterior. It is really fun to shop on the internet and so far pretty easy to find what I need. My general theme for the renovation will be to reuse what I can and modernize existing fixtures.

For example, Grote produced the original exterior marker lights. They are still in business and the exact same lights remain available.

I will modernize them by selecting the optional LED elements that use far less energy and last much longer. They are exact replicas on the outside but with modern light elements on the inside. The new refrigerator vent cover, plumbing vents and stove vent cover are made out of a more durable UV resistant plastic but in the exact shape of the originals. I also ordered curved replacement glass for the two non-original plastic windows. I ordered new rubber seals and stainless steel hardware for the windows.



Let us now look around inside. At first glance it does not look too bad but let us look a little deeper. The cabinetry containing the re-

frigerator is pulling away from the wall. Some of the original nine-inch floor tiles remain under the seating areas. I am very certain they contain asbestos and will need to go with special handling. I do believe I see daylight through that crack in the floor as well as likely floor rot. The rear bath is going to be a challenge. The former owner cut away a plastic bench to install a



new toilet leaving a gaping area where you can see into the bumper compartment and again daylight through the floor.



The full extent of the restoration is yet to be discovered. As the interior is dismantled areas that need attention will be discovered. We look forward to discovery and designing/building with quality materials.
