### A Message from Your Treasurer

As your treasurer, I'd like all members to know how their dues are spent. Of the \$65.00 sent to me, \$55.00 goes to headquarters for your International dues. This money covers your subscription to the Blue Beret, a copy of the International Directory, and the rest goes to defray the cost of the Office staff at Jackson Center, OH.

The \$10.00 that I retain goes into the Florida Unit treasury which, you must realize by now, does not fully cover the cost of printing and mailing the Unit newsletter. To defray some of this cost, those of us that have computers receive the newsletter via email. This saves the Unit a portion of the \$41.00 a month estimated cost of printing and mailing hard copies to each member. (This figure is based on our total membership of 76, using \$.41 for mailing and about \$.05 a page printing.) If we have to send out a reminder to everyone whose Unit dues are due, that additional cost also comes from a portion of another \$31.00, which is what it would cost to mail the newsletter at \$.41. At our Volunteer/Installation Rally at Fort Christmas, the Unit subsidizes approximately \$6.00 a member. If there are 2 attending members, this comes to \$12.00 from the \$10.00 of each unit member's dues.

What I am trying to make clear is this: for the \$10.00 you pay, you are getting back more than double in benefits. Not only do we subsidize the Ft. Christmas Installation Rally, we also subsidize informal luncheons at Region, Florida State and International. If you have the ability to attend these functions and do not take advantage of these benefits, you are missing out on a good time, and we are missing you.

Our Unit, **as all Units should be,** is run as a non-profit Unit and I feel it should continue to be run as such. If for any reason we make money on a rally, it is retained in the treasury and spent back on our members. We usually start each year with the Florida Unit treasury at around \$2,000.00.

If for any reason you cannot receive the newsletter via email, please let Ellen McMillan know. She will be more than happy to mail you a hard copy, in color!

The Florida Unit is the second largest Unit in Region 3, and it is a growing Unit because of the way your officers run it. We are all volunteers and we need you. **PLEASE TRY TO ATTEND IF AT ALL POSSIBLE.**

If you have already sent in your dues, I thank you very much. If you haven't, please do as soon as possible. Joan and I are looking forward to a trip out west this fall and I'd like to have this all completed before we leave. Thank you for being faithful members, I really do appreciate it.


