In Albuquerque we watched a beautiful sunset as we dined at the High Finance Restaurant. To reach the restaurant we rode on the world's longest aerial tramway which climbs to an altitude of over 10,000ft.

We rode a train from Durango to Silverton, CO, and got to enjoy a fresh snowfall. We were at the Green Corn Dance also on a very cold day. The Indians danced in family groups and the children were

adorable. We were invited into one of the homes where we were served drinks and pastries. They were very friendly. The visit to the Church of the Holy Dirt was interesting and we all were given a plastic bag of "Holy Dirt" to bring home. At Pagosa Springs, NM, there were 17 pools with temperatures ranging from 94 to 114 degrees. We enjoyed the cooler pools. We also visited the Atomic museum, Carlsbad Caverns, rode trucks through a beautiful Indian canyon, and visited a UFO museum. At Page, AZ, we took a boat trip on Lake Powell and a raft boat ride on the Colorado River. We saw a large number of mesas, bluffs and mountains that were just spectacular in size and color. At Jacobs Lake, we traveled 44 miles to the north rim of the Grand Canyon. Marie counted 186 deer on the way to the Lodge. Our caravan ended at Jacob's lake after 44 days of traveling and enjoying our beautiful country.
