BLUEGRASS FESTIVAL RALLY; MARCH 13 – 18; FT. CHRISTMAS, FL

Come join us at Fort Christmas, Florida for the Bluegrass Festival Rally. This event is similar to our Cracker Christmas event, except the crowds are smaller and there is somewhat less work to do. During the weekend, professional Bluegrass bands will be playing continuously during the festival.

Fill out the coupon in the back of this newsletter, and mail your registration back to Frank Carson. Parking committee only on Monday, March 11. Early parking starts on Tuesday, March 12.

The rally fee is \$10.00 per person. Parking is free with rally electric and water. The meals included in your rally fee are: Wednesday evening, hoagie supper; Thursday morning, pancakes; Friday evening, barbecue pot luck, (everyone bring a side dish to feed 6 to 8); Saturday morning, pancakes and sausage; Saturday afternoon, lunch; Sunday morning pancakes and sausage; and Sunday afternoon, lunch. That's seven included meals.

Please send in your reservation (coupon at the end of this newsletter) by March 6. This rally is by reservation only since the Unit must buy provisions for the meals ahead of the rally.

Attention Weekenders: If you can only come for the weekend, there is no rally fee. You may come anytime on Friday, but you must be onsite by 9:00 a.m. Saturday.

Attention First Timers: For those of you that have never been to this rally, it is completely laid back with professional Bluegrass bands playing continually both Saturday and Sunday. This is a volunteer rally, with not too much work. Make us proud. Show your support for the Orange County Parks, Fort Christmas and especially our Unit!

THE KEYS TO THE TROPICS RALLY; APRIL 4 – 11; MARATHON, FL

We need a minimum of 10 Airstreams to have the rally at this price. Please call or email Frank Carson (321) 704-2568 fc23343@aol.com by March 7, 2013, to let him know you are attending so he can make the campground reservations. The parking fee per site is \$30.00 per night which includes water, 30 or 50 amp electric, sewer and cable. The rally fee is \$5.00 per Airstream unit based on 1 or 2

per Airstream. We have two-day tickets for the Conch Trolley Tour this time for \$24.00 per person. You will have on and off privileges for two days. You can choose your days you wish to be at the rally, and you can stay longer at the same price per night. Please see the coupon in this newsletter.

REGION 3 "RALLY 'ROUND THE ROCK"
APRIL 23 – 26, 2013 STONE MOUNTAIN, GA

The rally will provide four breakfasts prepared by various units and two dinners. One dinner will be a low country boil prepared by the Georgia Unit and the other will be a steak dinner where you grill your steak (provided by the region) and enjoy salad and baked potato. We will have outdoor movies and the laser show of Stone Mountain for entertainment. Also officer training and several seminars will be presented.

Registration is open. Be prepared, and make the necessary decisions before you contact the Park. The Park's numbers are (770) 498-5710 or (800) 385-9807. The campground registrar will need (1) The dates you wish to attend, (2) Any handicap provisions you require, and (3) Whether you are choosing to purchase tickets for the bus tour of Atlanta (\$60 per person). Everyone will prepay the rally fee of \$55 per person over 15 years of age. The site cost for the first three days will cost \$49 each and will include the Premium Rally Package. Additional days will cost \$45 each. If your plan is to attend for only 2 days, the site cost will be \$45 per day and cannot include the Premium Package content. More details follow in the last paragraph.

Registration will close on April 2, 2013 allowing any uncommitted sites within our 150 site reservation to be sold to the public. The reservations for our handicapped area will close on March 19, 2013, to allow these sites to be reserved by other WBCCI members. Any registration requests arriving after April 2 will be placed in unassigned locations closest to our facilities. All sites have 3-point hookups. Any cancellation requests must be reviewed and approved by a member of the Region leadership team. The Park will not honor them without this approval.

A dozen of the sites we have reserved are pull-thru sites for motorhomes. On these sites, the

utilities are located closer to the front (rather than the rear) of the site. These are located at convenient positions for these members to view Mountain Lake from their motorhomes.

We are the last group to be offered the Premium Rally Package. This a Duck Tour, Laser Show seating with popcorn and soda, a special Antebellum Plantation tour, and an extra ice cream social. The Park has decided not to continue this program but

is honoring their commitment to offer it to our rally.

Special provisions have been made for members choosing to attend for only two nights. We recognize many members have employment and family commitments that do not allow them to attend the longer event. They will enjoy this wonderful family park experience, be permitted to attend the Park's annual "Spring Fling" that includes fishing, games, rides, snacks and a live magician show.

WOUNDED WARRIORS PROJECT (WWP) FUNDRAISING REPORT

The WWP is moving forward with initiatives to meet everyone's needs. Our T-shirt, which includes a logo of the US Flag, a Wounded Warrior and an Airstream trailer are selling like hot cakes. We sold 16 T-shirts prior to the Florida State Rally and 48 more at the Rally. We handed out order forms at the Rally and anticipate getting more orders in the mail.

The WWP Committee (Janet McGloin, Patsy Barr, Chris Allen) designed, printed and assembled cross stitch kits with an Airstream parked at the beach under a summer sun. We put together 12 kits for the FL State Rally Flea Market and all were sold out within an hour. We are making more kits to take to Region 3 at Stone Mountain along with more T-shirt order forms.

With a generous single donation received of \$500 towards our fundraiser, proceeds from the open house at Fort Christmas in December, and the T-shirts sales and cross stitch sales, we have collected \$1,738.56 to take to the International Rally in June. We hope to increase that amount as we continue our initiatives throughout the year.

Thank you to everyone who has supported our fundraiser. Without your support all this would not have happened.

THE 40TH FLORIDA STATE RALLY HAS PASSED INTO HISTORY

From all accounts and comments it was the best rally ever. Larry Scovotto my Assistant Director and Treasurer, and I did what we started out to do; take the rally in a new direction to increase attendance. We had limited success.

I want to thank Larry for all his hard work. Were it not for him and his vast skill set, there would not have been a rally. I am deeply indebted to him.

I had hoped to get over 400 registrations. We budgeted for 320 and we met that goal. Saturday night we had 341 RVs on the grounds with 10 offsite registrations. That is up from 316 last year. Financially, the rally had a net gain of around \$4,100.00 before taxes.

Frank Bates's RV and Airstream Show brought in more patrons for the Trade Show which had 25 vendors, up from last year's 20. Frank also brought in a Hot Dog vendor and the Airstream Boutique to sell Airstream memorabilia. I had hoped for more vendors but what I didn't know was that there were three other large trade shows going on the same week in Florida and our rally was not big enough for them to give up a sure thing for a less lucrative show.

One vendor who is special to us is A&W Designs. Wes Hurner made our FSR Logo for free. We also had him screen print the vests we wore at the rally. Wes and his wife made the decision to come to our Trade Show with their equipment rather than go to a much bigger, more lucrative show. Wes sent his wife to that Trade Show to take orders only. That decision, I'm sure, cost them some revenue.

I had called Wes and told him that it would be O.K. with me if he took his machines to the other trade show. His response was, "The Airstreamers expect us to be here. I feel we have an obligation to the Airstreamers to be here with our equipment and we intend to honor that commitment." You cannot buy that kind of loyalty. The flip side of that is Atwood. Atwood bought out Fantastic Vents who always came to the rally, performed maintenance on their fans for free, and sold a lot of product. Even though Airstream uses Fantastic Vents in their new units and most of us have installed them in our coaches, they blew us off. We made several attempts to persuade them to come and the answer was a resounding NO!

The merging of the Volunteers Hot Dog picnic and the Chairmen's Appreciation Dinner into the Chairmen and Volunteers Appreciation Dinner was a big success. The food at the fairgrounds is vastly improved over previous years. Everyone loved it. Rory Martin, Fairgrounds President, has made big improvements in that area. The Saturday dinner of Chicken Parmesan was delicious. There was so much food; people were taking *doggie bags* back to their trailers.

We had the old standby games of Bridge, Joker and others. There were lots of seminars: two put on by Dave Schumann from Airstream and two by Howard Lefkowitz from the *Blue Beret*.

So, with all this success, why did I recommend to the Board closing the rally down?

Perhaps excerpts from my Director's Report for 2013 will help to explain:

The 2012 Rally

- The treasurer for the years 2008, 2009, 2010 and 2011 did not submit the required IRS form 990EZ for the years 2008, 2009 and 2010.

- On May 7, 2012 I was blindsided with a notice from the IRS through Cindy Reed at Headquarters that read: "Your organization's tax-exempt status has been revoked automatically because you have not filed for three years" (If it weren't for Larry, I would have thrown in the towel and let the rally die right then.)

- While we had a net income of \$3,354.00 the lion's share of that was eaten up by penalties, administrative costs and taxes as a direct result of our loss of exempt status.

- We are still operating without an exempt status and will for the next months. With the climate in Washington, we may not see it again.

The 2013 Rally

- When I took over the rally it was dying on the vine. Attendance was on a downward trajectory.

- In 1997 we had over 1000 WBCCI Airstreamers attend.

- In 2011 we had around 450 attendees.

- In 2012 we had 316.

- This downward trajectory meant that if we didn't do something extraordinary, the rally was dead. We were down to the hard core attendees and that is an aging and diminishing group.

Summary

- As an organization we need to decide whether or not to continue the Florida State Rally in its current form.

- For 2014 we will need the following staff: Director, Treasurer, Webmaster, Assistant Director, Registrar, Assistant Director for Entertainment and Prizes, Assistant Director for Games and Food, Assistant Director for Trade Show.
- Without an across the board infusion of younger chairpersons more and more of the current position will become unfilled as the rigors of aging take their toll.
- The Directorship and Assistant Directorship are full time jobs. Larry and I have had to eat and sleep the FSR.
- Just because we made some inroads into improving the rally doesn't mean that our successors will have the same dedication to the course we have set out on. We also don't know if the improvement in attendance is just a one time aberration.
- If we decide to close the FSR down after this year, that doesn't mean that there won't be an Airstream rally in Florida in February. R&B Events is very interested in producing a rally as a replacement.
- We are no longer the youngsters we once were. The sad fact is we are a diminishing resource without any replacements on the horizon.
- So, I leave it up to the board to decide what the future holds for the FSR.

As I met our marvelous volunteers I came to realize that in one or two years we were not going to have the personnel needed to support the rally due to the ravages of aging with few if any replacements waiting in the wings. This year I had 84 Chairman and 120 volunteer positions. That's a lot of positions to keep filled.

At the February meeting of the Board of Governors, I presented my Director's Report. The board voted, unanimously, to disband the Board and open up the time for R&B Events to put on a rally. There was a lot of discussion before the vote, but we all saw the writing on the wall. The aging of the volunteer population with no younger folks coming along to replace them, the need for QUALIFIED volunteers to fill the Directors and Treasurer positions (and there being none), all lead to the Board's decision. The decision to disband has the full support of Region 3 officers as well as other ranking officials in the WBCCI. Once all the outstanding bills and taxes are paid, the net financial holdings of the Florida State Rally will be apportioned to the eight Florida Units based on their voting membership as of June 1, 2013. That is the date the official count for the Unit voting membership for the International Membership meeting is set.

I did not want to leave the February time slot open without an

Airstream based rally for all of us to attend and enjoy. To that end, before the Board meeting, I contacted Rich Luhr and Brett Greiveldinger to see if R&B Events would be interested in producing a rally in this slot. They were more than interested. They had been looking for a venue to have a rally in Florida. I felt that if the board decided to drop out of the rally then this would be the perfect time for a smooth transition.

So, the Florida State Rally is gone; But we will have an Airstream based rally with a fresh approach in February, at the Sarasota Fairgrounds in Florida. It will be **Alumaflamingo**. For the first time in over 40 years, the FSR volunteers can relax and enjoy themselves instead of working their tails off.

Alumaflamingo will be held February 18-23, 2014 at the Sarasota Fairgrounds. You can sign-up at www.alumaflamingo.com.

I want to thank all of the wonderful volunteers who made me look good as Director and put on a great rally. Many of them are from the Florida Unit.

The Unit with the largest representation at the rally was the Georgia Unit with 25 RVs. The Florida Unit was second with 22.

I hope to see you all next year at the Alumaflamingo.

FLORIDA UNIT HAS A NEW UNIT FLAG

Our new Unit Flag was used at the opening ceremony of the Florida State Rally and presented to our members at the FSR Unit Luncheon. Thank you Larry Scovotto and Dan Maciejczyk for making this happen for our Unit. It is one fine looking flag. We will display it with pride.

We are taking orders for 2' x 3' mini flags, that are one sided with grommets. This flag can be flown alone or placed under larger flags on your flag poles. We currently have seven orders for flags. Custom 12" x 18" Garden Flags with the Florida Unit logo are also available. These flags are single sided and have a pole pocket on top for use with a garden pole. Pricing for garden flags starts at \$28 each for quantities less than 3 and decreases from there to \$19 for quantities of 25 or more.
