### **Proposed WBCCI Amendments**

To: Membership of the Florida Unit 027  
From: Victor Smith, President Florida Unit  
Subj: Proposed Changes to the WBCCI Constitution

I sent an email to the members of the unit with my assessment of the changes to the WBCCI Constitution. Here is an abridged summary of the changes and some comments. I have been asked by the Region 3 President to respond by 31 Jan 2007 with a sense of the unit regarding the proposed change. Please contact me by email or by phone with your feelings on this matter.

These are the proposed changes.

Members at Large are given the right to vote.

The weight of the Unit membership is removed from the Unit Delegates. It changes election of officers from the Delegates voting the Unit membership to elect International officers to a ballot printed in the Blue Beret and to be mailed to the WBCCI for counting.

It also stipulates that the Delegates now have one vote on all matters.

The definition of a quorum is changed from 20 percent of the Delegates selected to participate to 51 percent of the total number of units operating with a permanent Unit Charter.

Nominations from the floor are deleted.

The biggest change is to Article XVI

Article XVI is changed to allow any member of the WBCCI to submit an amendment and removes the power of the International President to submit an amendment.

***The following is the inserted paragraph in Article XVI which I cannot condense in any meaningful way.***

Delegates participating in the annual Delegates Meeting may debate and amend any motion that comes before it. With the passage of any motion by the delegate body (51%), the motion must then be formalized and sent out to the membership for a final vote. Under the direction of the IBT any passed motions must be prepared to appear on the post Delegates Meeting ballot. The Executive committee shall select two members. One member in favor of the motion to prepare a pro statement and one member that is against the motion to prepare a con statement within a stated maximum length to accompany the proposed amendment. If no member can be found against the motion the Executive committee can select

someone who can create a plausible con statement. These statements will be appended to the annual post-Delegate Meeting ballot for voter consideration. The original authors of the amendment must provide complete rationale for the amendment. The rationale must detail all costs involved in the change and any and all changes in the constitution and by-laws in order to facilitate said change. If second or third parties are required to be involved as a result of a change, due diligence must be made to assure that any arrangement with the outside party will not cause additional changes to the International Clubs' Constitution or Bylaws beyond what has been called out in the proposed amendment. All documents required to facilitate any amendment

### Attention! Dometic Recalls Refrigerators

Models affected: NDR 1062 9999, RM 2652 9999, RM 2662 9999, RM 3662 9999, RM 3663 9999, RM 3862 9999, RM 3863 9999

Dometic has recalled 926,877 faulty refrigerators manufactured between April 1997 and May 2003. Recall No. 06EO76000

A fatigue crack may release a sufficient amount of pressurized coolant solution into an area where an ignition source (gas flame) is present. The release of coolant could ignite and result in a fire.
